



YEAR-END GIVING DEADLINES

InFaith Community Foundation follows and adheres to all IRS year-end giving deadlines.

GIFT TYPE	GIFT DEADLINE	MORE INFORMATION
Cash	December 31	<ul style="list-style-type: none"> • Must be USPS postmarked by December 31.
Checks	December 31	<ul style="list-style-type: none"> • Must be USPS postmarked on or before December 31. The IRS does not permit the postmark from an alternate private delivery service (e.g., UPS, FedEx or other private delivery service). When checks are sent by one of these services, the gift date is the date we receive the check. Send the check through USPS to ensure the gift is recognized in 2018.
Mutual Funds & Publicly-Traded Securities	December 10	<ul style="list-style-type: none"> • Initiate these gifts by December 10 to ensure arrival in InFaith’s brokerage account before year-end. While most stocks can be transferred within a week, certain stocks can take two to six weeks longer. Please call InFaith at 800-365-4172 about stock transfers so the gift is anticipated and directed to the appropriate donor advised fund.
Paper Certificates	December 31	<ul style="list-style-type: none"> • Certificates must be received in good order by December 31. Please call InFaith at 800-365-4172.
Real Estate	December 31	<ul style="list-style-type: none"> • Real estate gifts for 2018 will be executed on a best efforts basis, but we can begin the process for a 2019 gift. Please call InFaith at 800-365-4172.
Signed Fund Agreement	n/a	<ul style="list-style-type: none"> • In all cases, we must have a signed Fund Agreement before donor gifts can be accepted.
Wire Transfer	December 31	<ul style="list-style-type: none"> • Please contact InFaith at 800-365-4172. The gift must be received by InFaith on or before December 31.
Web Contribution	Received by 11:59 p.m. CT on December 31	<ul style="list-style-type: none"> • Please contact InFaith at 800-365-4172. The gift must be received by InFaith on or before December 31.

While **grant recommendations** from an InFaith donor advised fund are not taxable, to help ensure your favorite charities receive grants by year-end, InFaith must receive a *Grant Recommendation Form* by December 26. This form is on InFaith’s website under “Manage Fund/Login.”
